### 3-2-1 Rules 2025

- 1. Bowlers are permitted to bowl more than once. Can only cash once in the top 5 with the same team.
- 2. If there is a tie for first place prize money, first and second place prize money will be divided equally.
- 3. Team handicap is based on 90% of 690, doubles 90% of 460, and singles 90% of 230.
- 4. Entrants will use their highest USBC certified official book average based on minimum of 21 games for the 2023-24 season. If no average from last year, use this years highest book average with 21 games bowled. If not applicable, men will come in with 230 average and women to come in with 200 average.
- 5. 10 pin rule is in effect while bowling. If your average is 10 pins higher on the day you bowl, then you must use the higher average.
- 6. Sport bowling members or challenge league must comply with the requirements outlined in chapter 5 (USBC sport bowling) of the USBC rule book. The average conversion chart found on Bowl.com and in Average books will be used to adjust sports shot and challenge shot averages properly.
- 7. Rule 300c will apply in this entirely (tournament eligibility)
- 8. Rule 313 will apply in this entirely (tournament eligibility)
- 9. Rule 308 100% of the prize money will be returned to entrants.
- 10. In order to place more than once in the top 5 spots for team and doubles, 1 bowler must be changed. Singles you may only cash 1 time in the top 5.
- 11. Rule 319a 1,3, and 4 will apply.
- 12. Rules 319c the average of a bowler may be adjusted upward before the entrants bowl. IF the assigned average is not accepted by the bowler, the entry fee shall be refunded.
- 13. Rules 319d, 391e, 321, 322a, 324b, and 325 will apply.
- 14. If the USBC, your local association, or any tournament has re-rated your average, you must use that re-rated average. If you have been barred or disqualified, or you refused a re-rate, you must report that fact to the tournament official at time of check in prior to bowling. Failure to do so will result in disqualification. This rule includes reporting of all certified and uncertified tournaments, including those using a modified format of American Ten Pins (example: 9 pin tap).
- 15. Should any rule questions or infractions occur other than the rules stated on the entry form, the official USBC tournament playing rules book for 2024-25 will be enforced.
- 16. Rule 303 will apply in its entirety. Director reserves the right to refuse any entry for any reason.
- 17. Tournament management reserves the right to re-rate entrants prior to bowling.
- 18. Must check in half hour before squad time.
- 19. Only one current PBA members per team.

The entrants whose names appear hereon or their authorized replacements hereby agree that the 3-2-1 Tournament, its officers, and agents shall be liable only to the extent of returning entry fees if and when these entrants shall be prevented from bowling any event in the tournament through delay, unexpected yet necessary schedule change, or premature termination of the tournament, which may be brought about by war, national emergency, or emergencies or causes relating thereto or resulting therefrom, fires, strikes, lockouts, labor difficulties, or other causes beyond control of the 3-2-1 Tournament.
